Marking, Packaging, Transportation and Storage for Garments

1 Scope

This Standard specifies the general requirements for marking, packaging, transportation and storage of garments.

This Standard is applicable to various mass-produced garments.

This Standard is inapplicable to mass-produced garments where the contracting parties have otherwise agreed on the technical requirements for marking, packaging, transportation and storage.
