### **Foreword**

All technical content of this Part is mandatory.

GB 4706 Safety of household and similar electrical appliances consists of several parts. GB 4706.1-2005 is general requirements. Other parts are particular requirements.

This Part is Part 61 of GB 4706. This Part shall be used in conjunction with GB 4706.1-2005 Household and Similar Electrical Appliances - Safety - GB 4706.1-2005: General Requirements.

The section indicated with "Application" in this Part means that the corresponding terms of GB 4706.1 are applicable to this Part. The section indicated with "Replacement" or "Modification" in this Part means that this Part shall prevail. The section indicated with "Addition" means that in addition to corresponding terms of GB 4706.1, it shall also comply with the terms added in this Part.

This Part identically uses IEC 60335-2-54:2007 Household and similar electrical appliances - Safety - Part 2-54: Particular requirements for surface-cleaning appliances for household use employing liquids or steam (Edition 3.2).

This Part replaces GB 4706.61-2002 Safety of household and similar electrical appliances - Particular requirements for surface-cleaning appliances employing liquids.

The main differences between this Part and GB 4706.61-2002 are as follows:

- added wallpaper strippers in Clause 1;
- added 3.101;
- added 16.3: Current-carrying hoses, except for their electrical connections, are immersed for 1 h in water containing approximately 1% NaCl and having a temperature of 20°C ± 5°C. While the hose is still immersed, a voltage of 2000 V is applied for 5 min between each conductor and all the other conductors connected together. A voltage of 3000 V is then applied for 1 min between all the conductors and the saline solution:
- added 29.2: The microenvironment is pollution degree 3 unless the insulation is enclosed or located so that it is unlikely to be exposed to pollution during normal use of the appliance.

This Part was proposed by China Light Industry Federation.

# Household and similar electrical appliances - Safety Particular requirements for surface-cleaning appliances for household use employing liquids or stream

# 1 Scope

This clause of GB 4706.1-2005 is replaced by the following.

This Part deals with the safety of electric cleaning appliances for household use that are intended for cleaning surfaces such as windows, walls and empty swimming pools by using liquid cleansing agents or steam, their rated voltage being not more than 250 V. It also covers wallpaper strippers.

NOTE 1 Appliances may incorporate heating elements or means for pressurizing the liquid container.

As far as is practicable, this Part deals with the common hazards presented by appliances that are encountered by all persons in and around the home. However, in general, it does not take into account

- persons (including children) whose
  - physical, sensory or mental capabilities; or
  - lack of experience and knowledge

prevents them from using the appliance safely without supervision or instruction;

- children playing with the appliance.

NOTE 2 Attention is drawn to the fact that

- for appliances intended to be used in vehicles or on-board ships or aircraft, additional requirements may be necessary;
- in many countries, additional requirements are specified by the national health authorities, the national authorities responsible for the protection of labor, and similar authorities.
