#### 3 Terms and definitions

#### Allergen

The antigenic substances that can induce allergic reactions in the body.

3.2

#### Food allergen

The natural or artificial added substances that are normally existed in ordinary foods; it can induce allergic reactions after it is consumed by allergic people.
