Power quality requirements for electric vehicle charging/battery swap infrastructure

1 Scope

This Standard specifies the relevant standards and testing requirements of power quality for charging facilities of electric vehicles.

This Standard applies to the charging facilities of electric vehicles, including AC charging piles and charging stations.
