### **Foreword**

Part 3 Portable power tools of "Safety of motor-operated hand-held, transportable and garden tools" currently consists of the following two parts:

- GB/T 3883.306-2017 "Safety of motor-operated hand-held, transportable and garden tools Part 3: Particular requirements for transportable diamond drills with liquid systems";
- GB/T 3883.311-2019 "Safety of motor-operated hand-held, transportable and garden tools Part 311: Particular requirements for transportable cut-off machines".

This Part is Part 311 of GB/T 3883.

This Part was drafted in accordance with the rules given in GB/T 1.1-2009.

This Part replaces GB/T 13960.11-2000 "Safety transportable motor-operated electric tools - Part 2: Particular requirements for cutting-off grinders". Compared with GB/T 13960.11-2000, the main technical changes are as follows:

- added cutting objects such as concrete and masonry into the scope of application; added the use of diamond cutting wheels; clarified the type, line speed and range of the grinding wheel used; added the inapplicable scope of this Part (see Clause 1 of this Edition);
- in terms, added "inner flange", "bonded reinforced wheel", "cutting unit", "D", "diamond wheel", "fence", "outer flange" and "rest position"; modified "cutoff machine" and "wheel guard"; deleted "spindle", "clamping plate assembly", "straight edge groove clamping plate" and "workpiece fixing device" (see Clause 3 of this Edition, Clause 2 of 2000-Edition);
- In general test conditions, added the description of parts that shall be included in tool mass (see Clause 5 of this Edition);
- modified Table 4 of Part 1 in abnormal operation (see Clause 18);
- In mechanical hazard: added prevention of overspeed testing in 19.6; added the requirements for anti-dumping test and easy fixing of tools in 19.7; added the general requirements of grinding wheel protection in 19.101.1; modified the original 18.1.103, 18.1.104 and 20.17 to 19.101.2, that is, improved the requirements of the wheel guard; modified the original 18.104 to 19.101.3, and improved the protection of the grinding wheel under the table; modified the original 18.1.105 to 19.102, that is, improved the deflection of splashing; modified the original 18.101 to 19.103, that is, improved the fixation of workpiece; added the installation of 19.104

accessories; modified the original 18.102 to 19.105.1 and 19.105.2, that is, improved the general requirements and minimum dimensions of flanges; added the dimension requirements of diamond cutting wheel flange in 19.105.3; added 19.105.4 flange strength test; modified 18.103 to 19.106, and improved the requirements of tool spindle (see Clause 19 of this Edition, Clause 18 of 200-Edition);

- modified mechanical strength from 18.1.102 to 20.101 and 20.102; improved the strength requirements of the wheel guard (see Clause 20 of this Edition, Clause 18 of 2000-Edition);
- revised the structure from 20.18 of the original Part 1 to 21.18.2.1 and improved the requirements of the power switch; added non-applicable clauses corresponding to Part 1 (see Clause 21 of this Edition, Clause 20 of 2000-Edition);
- added 23.3 to corresponding Part 1 in components (see Clause 23 of this Edition);
- modified the power connection and the external soft wire from 23.2 to 24.4, that is, improved power cord material requirements (see Clause 24 of this Edition, Clause 23 of 2000-Edition);
- added the informative Annex I "Noise and vibration measurement" (see Annex I of this Edition).

This Part used translation method to identically adopt IEC 62841-3-10:2015 "Electric motor-operated hand-held tools, transportable tools and lawn and garden machinery - Safety - Part 3-10: Particular requirements for transportable cut-off machines".

The Chinese document which has consistency with the international normative reference in this Part is as follows:

- GB/T 4127.15-2007 "Bonded abrasive products Dimensions Part 15: Grinding wheels for cutting-off on stationary or mobile cutting-off machines" (ISO 603-15:1999, MOD);
- GB/T 34560 (all parts) "Structural steels" [ISO 630 (all parts)].

This Part made the following editorial modifications:

- changed the standard name to "Safety of motor-operated hand-held, transportable and garden tools Part 311: Particular requirements for transportable cut-off machines";
- this Part incorporated the content of IEC 62841-3-10:2015/COR1:2016.

# Safety of motor-operated hand-held, transportable and garden tools - Part 311: Particular requirements for transportable cut-off machines

# 1 Scope

This clause of GB/T 3883.1-2014 is applicable, except as follows:

#### Addition:

This Part applies to transportable cut-off machines intended to cut materials such as metals, concrete and masonry and to be fitted with one abrasive

- bonded reinforced wheel of Type 41, or
- diamond cut-off wheel with the peripheral gaps, if any, not exceeding 10 mm;

and with

- a rated no-load speed not exceeding a peripheral speed of the wheel of 100 m/s with the maximum wheel diameter and
- a wheel diameter range of 250 mm to 410 mm.

**NOTE 1:** Unless otherwise specified, the "grinding wheel" in this Part includes the "bonded reinforced wheel of Type 41" and "diamond wheel" specified in the scope.

This Part does not apply to:

- transportable miter saws;
- transportable tile saws;
- transportable metal saws.

**NOTE 2:** Transportable miter saws are covered by IEC 62841-3-9. Transportable tile saws and transportable metal saws will be covered by a future part of IEC 62841-3.
